REQUIREMENTS AND INSTRUCTIONS

1. Applicant must be 21 years of age, speak, read, and write the English language, and have a thorough knowledge of the provisions of the Vehicles for Hire City Code Chapter, the Traffic Ordinances of the City of Decatur and of the geography of the City of Decatur.
2. Vehicles for Hire drivers' licenses shall be valid commencing on the first day of May of each year through and including the thirtieth day of April, following. The fee for each license and/or renewal is nonrefundable in the amount of \$25.
3. Vehicles for Hire drivers' license applications shall include three (3) copies of a recent photograph of the driver not less than 4"x4" in size, at least 75% of which shall show the applicant's face, head and shoulders.
4. **ANY FALSE STATEMENT MADE BY THE APPLICANT SHALL BE GROUNDS FOR DENIAL OR REVOCATION OF PRIVILEGES AND SHALL BE PUNISHABLE BY A FINE OF NOT LESS THAN \$250 OR MORE THAN \$500.00. In addition, such false statement shall be reported to the State's Attorney of the County of Macon, for potential criminal prosecution.**

In consideration of the granting of the license hereby applied for, applicant agrees that service of any paper, notice, letter, summons, complaint or legal process of any kind or nature may be made by the City of Decatur, or any Department thereof, upon the person to whom the license is issued, by leaving a copy of any such paper, notice, letter, summons, complaint, or legal process with any member of his/her family or other person with whom he/she may reside at the address provided on the application or any written modification of the information provided on this application.

Applicant agrees to report to the Decatur Police Department every accident in which he/she is involved which results in either personal injury or property damage.

Applicant further agrees to comply with all rules and regulations of the City of Decatur governing Vehicles for Hire and Vehicle for Hire Drivers.
