ANYONE who provides renovation or maintenance work for homes, schools or daycare centers built before 1978 MUST complete this training under EPA & Federal law.

The City of Decatur's Neighborhood Revitalization Division wants your help to fight lead-poisoning!

- WHO?** Painters, renovation, and repair contractors, building code officials, regulators, residents, parents, landlords, vocational trainees & staff working with contractors.
Must work or live in the local area, be at least 18 years of age, and be available for 8 hours, one day only. Must understand and read English, although exam can be read out loud to assist students. Must show state photo ID for proof of residence for EPA. Please note your photo will be taken and is required for your certification. Certificate is emailed after exam to host and trainees.
- WHAT?** Lead-based paint renovation training for residents, contractors, or service providers in your area:
- Youth Build trainees and/or other apprentice programs, profit/non-profit groups.
 - Renovators, painters, window installers, housing maintenance staff, electricians, HVAC specialists, plumbers, floor finishers, as well as landlords performing any of the same tasks.
 - Any worker who removes windows or disrupts more than 6 square feet of paint in pre-1978 homes, schools, daycare centers, even if vacant, must comply.
- WHY?** **It is the law! This law cannot succeed without local outreach for prevention in all housing infrastructures.**
- Avoid poisoning children, prevent insurance lawsuits, and offer more than some competitors.
 - Protect yourself, your workers, customers, and your own children from serious health risks.
 - Lead dust on children's hands can cause irreversible brain damage.
 - Attract new customers on the EPA's website directory as a **Lead-Safe Certified Renovation Firm.**
