Upcoming meeting dates: Feb 8th board member meeting planned. March 7th another meeting planned. Go over strategy. April 11th. July 11th meeting before farmers plant cover crops. Dec. 11th.

## **Priority Areas:**

If someone in the group has experience with certain practices, then we can coordinate with that person. We can add expertise info on "promo" sheet for contact information. Not just board members but others outside this group that have experience.

Create a list of people making contributions, or a partner list. We can continue to expand this list if you know of someone who fits the description.

Outreach will start organically and possibly transitioning to assigning a sub watershed to each member

How should we coordinate amongst the group? A google sheet could work.

Jeff has created a Dropbox.

Jeff will finish Mindsalt setup (assign managers to board members) Will create an AFT section. Jean/Shelby are managers.

#### **Outreach Material:**


The RCPP sign up portal was created Jan. 8th Taking applications now. We can assist signing farmers up, they can call Jen and she can print applications for them. Deadline for accepting applications is March 28th Contracts will be active for crop year 2025.. Technical service providers will be working for farmers by 2025.

A minimum of 2-year contract and max of 5 year. Make the NRCS estimates cheat sheet public facing

If questions come up about certain practices i.e. bioreactors, you can send them to Jeff and Jen

Quint can respond to TSP questions.

- a. Election of Officers Chairman and Vice Chair: Cody White (Chairman) Tony Stierwalt (Vice Chair) The Chair and Vice Chair will represent this group to the public. It is important that producers are the point of contact for farmers interested in the program.
- Time tracking software- Mindsalt. Board members will track time spent conducting outreach with this software. Managers can track and approve the time spent.
